The Board of County Commissioners of Madison County, Nebraska met in regular session at 9:30 A.M.

Advance notice of meeting was published in the Thursday, February 26, 2009 edition of The Norfolk Daily News. A copy of said notice was mailed to each Board member. An affidavit of acknowledgment of receipt of notice of meeting as published was executed. Chairman McCallum called the meeting to order and notified the public of the location of the information regarding the Open Meeting Act posted in the meeting room.

Present: Commissioners Jerry McCallum, Rick Uhlir, and Lee Klein, and County Clerk Nancy Scheer. County Highway Superintendent Richard Johnson joined the meeting at 9:55 A.M. County Weed District Board Member Myron (Mike) Nelson was present from 9:48 A.M. to 10:51 A.M.

Chairman McCallum read the following consent agenda items into the record:

RESOLUTION #2009-6

WHEREAS, Faith Regional Health Services proposes to expand their telehealth system with planned expansion in the communities of Atkinson, Bassett, Creighton, Neligh, Pender, Plainview, Tilden, and Wayne, and

WHEREAS, the proposed telehealth system expansion includes remote monitoring capability with specially trained staff at Faith Regional Health Services and bedside cardiac monitoring with wireless patient-worn monitor system, and

WHEREAS, the proposed telehealth system expansion would further increase the expertise of specialty physicians to the rural hospitals in their service area by offering psychiatry, infectious disease, nephrology, cardiac testing and monitoring, and clinical consultations, and

WHEREAS, the proposed expansion of the telehealth system would provide substantial benefits to the residents of the rural communities, and

WHEREAS, Faith Regional Health Services is requesting grant funding through USDA Distance Learning/Telemedicine to assist with costs associated with expansion of the telehealth system,

NOW THEREFORE BE IT RESOLVED, that the Madison County Board of Commissioners hereby supports award of a USDA Distance Learning/Telemedicine grant to fund the telehealth system expansion project proposed by Faith Regional Health Services.

RESOLUTION #2009-7

WHEREAS, the Nebraska Department of Roads (NDOR), under direction of the Federal Highway Administration (FHWA), is currently writing a new Local Public Agency (LPA) manual, providing for policy and regulations to be implemented on local federal aid projects, with the intention of adopting the manual on March 9, 2009; and

WHEREAS, it has come to the attention of the Board of Commissioners of Madison County that, based on 23CFR1.33, the design engineer for a federal aid project will not be allowed to provide construction management services on the same project and a county highway superintendent or city street superintendent will not be allowed to provide either design engineering services or construction management services on any federal aid project; and

WHEREAS, the Board of Commissioners of Madison County finds that the above requirements are an arbitrary and capricious interpretation of 23CFR1.33 and will create a hardship to the local agencies by adding additional costs to each project and,

WHEREAS, engineering issues are only one item of concern in the proposed LPA manual and until it is reviewed by the local public agencies, it is impossible to know what other items will be detrimental to local public agencies and contrary to public interest; and

WHEREAS, it is the intention of the NDOR that the LPA Manual will not be made public until it is completed and approved by the FHWA thus allowing for no public input from the entities that it affects;

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of Madison County that the Governor of the State of Nebraska is respectfully requested and strongly urged to require the Nebraska Department of Roads to do the following prior to adoption of the Local Public Agency Manual:

1. Remove the requirements based on 23CFR1.33 as stated above.
2. Allow a 120 day public comment period prior to adoption of the LPA Manual
3. Conduct at least three public hearings across the state to receive local input
4. Provide citations from the Code of Federal Regulations or Nebraska Revised Statutes for all applicable policies in the Local Public Agency Manual and, where there is controversy regarding interpretation of law, obtain a legal opinion as to the validity of the interpretation.
5. Allow counties to approve policies that the FHWA or NDOR requests, but are not mandatory, prior to becoming part of the LPA Manual.

Motion was made by Uhlir and seconded by Klein to approve the consent agenda. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Motion was made by Klein and seconded by Uhlir to approve the regular agenda. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

The Board reviewed the following reports:

- 1) Fund balance report
- 2) Audited financial statements for the year ended June 30, 2008
- 3) 1st Quarter newsletter for CASA of Northeast Nebraska

The Board reviewed a tort claim submitted by the law firm of Walentine, O'Toole, McQuillan & Gordon, on behalf of Oliver C. Solorio for damages to Mr. Solorio's vehicle on February 18, 2008 when he crossed a railroad crossing located on the Fairgrounds Road. After discussion, it was moved by Uhlir and seconded by Klein to table the tort claim of Oliver Solorio. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Extension Office staff members presented the 2008 annual report to the County Board. Extension Educator Lee Sherry, Extension Educator David Kwaw-Mensah, Associate Program Educator Michelle Kroupa, 4-H Assistant Sarah Nelson, Healthy Communities Initiative Coordinator Brandy Boschult, and Extension Board members Dr. Jeff Rub and Terry Radenslaben were in attendance. Also in attendance were two members of the media and one member of the public.

Extension Educator Lee Sherry reported that 4-H member Laurel Rub received the Prudential Spirit of Community Award for donating over 100 hours of service to the community. Chairman McCallum presented the Presidents Gold Award to Laurel Rub and congratulated her on the award and service to the community. Laurel Rub reported that she completed a Kids Caring for Kids project that involved making 18 suitcases for children who were victims of abuse. She explained that the suitcases have a pillow, blanket, toy, and some overnight items.

Extension Educator Lee Sherry reported that the Extension Board consists of 9 members, and the 4-H Council has 14 volunteer members. She explained that the Extension Office is a division of the Institute of Agricultural and Natural Resources at the University of Nebraska in Lincoln cooperating with the counties and the U.S. Department of Agriculture. She stated that the Extension Office goals are to provide reliable, research-based information on agriculture and natural resources, consumer and family economics, community and economic development, and 4-H and youth development. Lee Sherry stated that the Extension Office slogan is "Know How Know Now" and the goal is simply to help put knowledge to work. She reported that UNL estimated for every dollar that the county spends for an extension budget \$5.63 in other dollars comes back into the county in the form of salaries, grants, staff development, equipment matches, specialists involvement, and administrative involvement. She stated that

the Extension Office budget of \$138,358 returns to the county \$778,955.54. In addition, she reported that approximately \$250,000 in grant funding was received during the prior year. Lee Sherry reported that she focuses on 4-H science and technology and she was project coordinator for the Children Youth Families At Risk (CYFAR) grant that ended April 30, 2008. She reported that she coordinated the Nutrition Backpack and Youth Adult Partnership programs. She also reported that additional classes offered through the CYFAR grant are English Language Learning, Nutrition Education, and the After School Program. She reported that Madison Elementary School offered the after school program with CYFAR grant funds and currently the program is funded through the 21st Century Learning Center grant. She stated that parents of the students enrolled in the after school program report that the grades of the students have gone up as a result of this program. Lee Sherry explained that staff members conducted the school enrichment GPS/GIS program. She reported that a new 4-H Robotics Club started last year and 150 youth in northeast Nebraska attended 4-H Robotics Camps to learn science, engineering and technology skills. She also reported on other programs offered by the Extension Office including Kids Talk About Divorce, Guardianship, Character on the Job, 4-H Leader/Youth Training, Child Care Conference, Health Fair, Water Days, Youth Adult Partnership, Project Days, Baby Sitting Clinic, Backpack Grant, and a Walk-A-Thon where participants pledged to live drug free.

4-H Assistant Sarah Nelson explained that the 4-H program is designed to help youth develop and utilize positive character traits, positive decision-making, communication skills, citizenship, community service, and leadership. She reported that the participation in the 4-H school enrichment program increased 6.2% from 2007 and that 2,378 youths were involved in this program in 2008. She stated that she works with 16 active 4-H clubs with a total of 277 members, 160 adult volunteers, and 12 youth volunteers. She reported that the Extension Office offers workshops throughout the year covering the 4-H curriculum including quilting, gardening, sewing, baking, and fishing. Sarah Nelson reported that the last two years the Extension Office has been a part of the Nebraska 4-H Action Team with science, engineering, and technology and within that program they are involved with robotics. She explained that the Extension Office also conducted a Quality Assurance workshop to make sure that the youth swine exhibitors are certified with pork quality assurance. In addition, she reported that the school enrichment programs offer Life on the Farm programs including Embryology, Microbes, Robotics, GPS Day, Bread in a Bag, Kids Growing with Grains, Bullydance, and Money Cents.

Michelle Kroupa, Associate Program Educator, explained that she works with the Nutrition Education Program, which is grant funded through the USDA. She reported that the grant funds must be spent on low-income families who qualify for the program. She explained that the program was implemented to help participants develop skills and learn behaviors leading to improved nutritional well-being. She reported that the adult nutrition programs include Norfolk Alternatives for Success, Women's Empowering Life Line, Head Start, Parent Night at Schools, and the CYFAR Backpack Program. Ms. Kroupa reported that she reached over 2,394 youth contacts through the youth nutrition education program presented at Head Start, Madison Elementary, Northern Hills Elementary, Grant Elementary, Lincoln Elementary, Washington Elementary, Jefferson Elementary, Westside Elementary, and Norfolk Senior School through the Alternative Education program. In addition, she reported that she made contact with over 200 seniors with nutrition education.

David Kwaw-Menash, Ag Educator, reported that he has been working with the Extension Office for seven months and replaced Tim Lemons. He reported that the soil is one of the most important natural resources and he works with the 4-H youth to get them excited about the soil. He explained that he focuses on conducting agriculture programs including pesticide and chemigation training. He reported on the pesticide training courses offered and/or planned for 2009.

Brandy Boschult, Healthy Communities Initiative Coordinator, reported that the Health Communities Initiative Project was formed out of a Partnership Grant between Elkhorn Logan Valley Public Health Department and the University of Nebraska-Lincoln to address alcohol misuse in the four counties of Madison, Stanton, Burt, and Cuming. She reported that the project priorities are to reduce and prevent alcohol and other drug misuse among persons 17 and younger, binge drinking among 18 to 25 year olds, and alcohol impaired driving across all age groups. She reported that the progress that has been made to date includes creating a mission, selecting priorities, selecting contributing factors and root causes, and completing the final needs assessment for the project. Ms. Boschult explained that they are working on the strategic plan that will be submitted to the state to apply for \$150,000 in additional funds and upon approval of the funding, they will begin implementation. She reported that she has conducted several town hall meetings and youth focus groups.

Chairman McCallum commended the Extension Office staff members for their service to the youth and adults in the county. The Board took no action.

Judy Stewart met with the Board requesting blacktop of one-half mile of 547th Avenue between 838th and 839th Roads. Ms. Stewart reported that 13 houses are located in a half-mile section on 547th Avenue and the traffic is tremendous in this area. She explained that the road is like a washboard, so she requested that the county consider putting a blacktop surface on one-half mile of this road. She stated that she knows it would be expensive and she was unsure how much tax funding was generated from the 13 houses located along this road. Mrs. Stewart clarified that the road she is requesting to be blacktopped is not the road within Char Dan Subdivision, but the county road that runs by the subdivision. She explained that the mile located north of the subject road is blacktop and no one lives on that road.

Chairman McCallum explained that the subject road is located within the extra territorial zoning jurisdiction of the City of Battle Creek and the county is not responsible for paving this road. He reported that Planning and Zoning Administrator John Johnson submitted a letter of explanation and County Clerk Nancy Scheer read the following letter during the meeting:

"I apologize that I am unable to attend the March 3, meeting of the Madison County Board of Commissioners due to medical treatment. I would request this letter be read into the record.

I would recommend the county **NOT** blacktop one-half mile of 547th Avenue between 838th and 839th Roads. This road serves the Char-Dan Subdivision which was controversial when it was approved by the Battle Creek City Council in 2003. It was recommended not to be approved by the Madison County Joint Planning Commission because the subdivision was not adjacent to any residential area of the City of Battle Creek. This subdivision lies within the City of Battle Creek's Extraterritorial Jurisdiction.

The approval of the subdivision by the Battle Creek City Council was done based on the subdivision roads would not be dedicated to the public and turned over to the county for maintenance and the portion of 547th Road serving the subdivision would not be paved. The fear was this could set a precedent to plat other subdivisions within the Extraterritorial Jurisdictions of other cities and then add the road maintenance and paved roads to the county road inventory. The subdivision regulations of the cities within Madison County (not including Norfolk) and the county say subdivisions be located on paved roads. This was waived in the Char-Dan approval.

My recommendation would be to only pave this portion of 547th Avenue if it is included in the 1 and 6 year Road Plan; if Char-Dan Road is also paved by the Char-Dan Home Owners Association; and, the Char-Dan Home Owners Association pay for the paving of 547 Avenue and any costs are not assessed to the other land owners along the portion of 547th Road requested to be paved.

The county planning and zoning jurisdiction begins at the end of the requested paving. This paving could justify a request to subdivide additional property south of the Char-Dan Subdivision as well as property in county and city jurisdiction along the proposed paving stretch of the road. The creation of any additional subdivisions in this area would be inconsistent with the Comprehensive Plan of Madison County and the Comprehensive Plan of the City of Battle Creek.

Thank you for your time and I again apologize for not being able to attend the meeting.”

After the letter was read, Judy Stewart requested a copy of the letter and stated that she was unaware of the circumstances surrounding the road past the subdivision. Commissioner Uhlir explained that the county does not receive enough tax dollars from the houses located along this section of road to make improvements to it. County Highway Superintendent Richard Johnson reported that improvements to 547th Road are not included in the one and six year plan. He explained that the Road/Bridge Fund would receive approximately \$200 for every house in this subdivision that is valued at \$100,000.

The Board took no action.

Convention and Visitors Bureau Director Lora Young requested to meet with the Board in executive session to discuss personnel issues between the Convention and Visitors Bureau and Norfolk Area Chamber of Commerce.

Motion was made by Klein and seconded by Uhlir to recess into executive session for discussion of personnel issues. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

The Board recessed into executive session at 10:51 A.M. with Convention and Visitors Bureau Director Lora Young, County Highway Superintendent Richard Johnson, and County Clerk Nancy Scheer present.

Chairman McCallum recessed the meeting from executive session at 11:05 A.M.

Motion was made by Klein and seconded by Uhlir to authorize Convention and Visitors Bureau Director Lora Young to serve as interim president of the Norfolk Area Chamber of Commerce, if appointed, not to exceed a period of six months. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Attorney Joseph Smith withdrew his agenda item for discussion on a personnel issue.
