The County Board reviewed the following reports:

Pursuant to published legal notice in the Thursday, August 28, 2008 edition of The Norfolk Daily News, Chairman McCallum opened a public hearing at 10:01 A.M. to receive citizens' comments regarding the proposed county budget for the 2008-2009 fiscal year.

One member from the public and two members of the media were in attendance.

Budget committee members Nancy Scheer and Richard Johnson presented a summary of the proposed budget. They reported that the proposed budget is \$28,299,265, which will require \$9,133,754 in property taxes. They explained that the proposed budget represents a decrease of \$70,508 from the prior fiscal year budget, which was \$28,369,773. Committee members explained that, in order to comply with statutory lid requirements, it was necessary to reduce the restricted funds by \$775,883 and that this was accomplished through the use of Inheritance Tax funds, spending cuts from the Road/Bridge Fund, and reductions in anticipated cash reserves. They also reported that the valuation increase of \$186,203,215 allowed an increase of allowable restricted funds in the amount of \$176,409 and that this increase was in addition to the statutory 2.5% increase and the 1% increase approved by the County Board on August 26, 2008. Budget committee members stated that 32.3% of the anticipated revenues would be collected from property taxes.

Roger Acklie requested clarification on the budget reductions that were approved by the County Board and budget committee members responded that the cash reserves in General and Road/Bridge Funds were reduced, expenditures in Road/Bridge Fund were reduced, and funds were transferred from Inheritance Tax Fund.

Chairman McCallum commended county officials for maintaining budget increases to 2% over the prior fiscal year. In addition, he thanked budget committee members for their work on preparing the budget.

Chairman McCallum closed the public hearing at 10:10 A.M.

After discussion, the following budget message was presented:

**MADISON COUNTY, NEBRASKA BUDGET DOCUMENT
BUDGET MESSAGE**

Pursuant to Section 13-501 through Section 13-515 Nebraska Revised Statutes (the Nebraska Budget Act), the Board of Commissioners herewith submits the budget for Madison County for the fiscal year July 1, 2008 through June 30, 2009. The total budget requirements of \$28,299,265 will necessitate \$9,133,754 being raised by taxation, and the balance of the total

requirements, \$19,165,511, will be provided by county officers' fees, governmental subdivision aid, highway allocation, motor vehicle tax, proceeds from the sale of bonds, reimbursement from various local, state and federal sources, delinquent taxes, 2007 taxes now in the process of collection, and unexpended cash balance. \$235,883 of the property tax requirements will be used to pay principal and interest on bonds to finance major road construction projects.

The County budget is not intended to be a line item budget; however, the Madison County Board of Commissioners hereby requests and expects all county officials and department heads to contact the County Board if any expenditure will greatly exceed the amount budgeted for that purpose. The County Board of Commissioners will not approve any claims when the total budget for any office or department exceeds the amount budgeted, unless additional appropriations are approved in the manner prescribed by law.

The Board of Commissioners recognizes the need for rural fire protection and has allocated levy authority, as prescribed in Section 77-3443 Nebraska Revised Statutes, to all rural fire districts at the rate requested. Levy allocations were also authorized for the Norfolk Sanitary District and the Madison County Agricultural Society. The County Board will attempt to allocate levy authority to these entities in future budget years, but encourages exploration of other sources of revenue due to future uncertainties.

It has been the policy of the Madison County Board of Commissioners to hold the tax levy to a feasible minimum. Madison County has no registered warrants.

Motion was made by Klein and seconded by Uhlir that the foregoing budget message be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

The following resolution was introduced for consideration:

RESOLUTION OF ADOPTION AND APPROPRIATIONS #2008-58

WHEREAS, a proposed County Budget for the fiscal year July 1, 2008 to June 30, 2009 prepared by the budget making authority, was transmitted to the County Board on the 19th day of August, 2008, and

WHEREAS, a duly advertised public hearing on said budget was held as required by Nebraska Revised Statutes,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Madison County, Nebraska as follows:

Section 1. That the budget for the fiscal year July 1, 2008 to June 30, 2009 as categorically evidenced by the budget document be, and the same is, hereby adopted as the budget for Madison County for said fiscal year.

Section 2. That the offices, departments, activities, and institutions herein named are hereby authorized, with County Board approval, to expend the amounts herein appropriated to them during the fiscal year beginning July 1, 2008 and ending June 30, 2009.

Section 3. That the income necessary to finance the appropriations made, and expenditures authorized, shall be provided out of the unencumbered cash balance in each fund, revenues other than taxation to be collected during the fiscal year in each fund, and property tax requirements for each fund.

Motion was made by Klein and seconded by Uhlir that the foregoing resolution be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

Pursuant to published legal notice in the August 28, 2008 edition of The Norfolk Daily News, Chairman McCallum opened a public hearing at 10:01 A.M. to receive citizens' comments regarding adoption of the property tax for the 2008-2009 fiscal year at an amount different than the prior fiscal year. One member of the public and two members of the media were in attendance.

Budget committee members Richard Johnson and Nancy Scheer explained that the reason for the second public hearing is to comply with state law that requires an entity to conduct a special hearing when the property tax requirement is different than the previous fiscal year. They reported that the proposed property tax requirement of \$9,133,754 is a decrease of \$100,341 from the \$9,234,095 property tax requirement in the previous fiscal year, which represents a 1.1% decrease. They explained that the anticipated property tax would require a levy of \$.387216 per \$100 of assessed property valuation, compared to a tax levy of \$.425021 per \$100 of valuation during the prior fiscal year, with the difference being a 8.9% decrease. Budget committee members reported that the portion of property taxes on a \$100,000 home, to fund the operations of county government for 2007 was \$425.02, and that the same homeowner will pay \$387.22 in property taxes for 2008, a decrease of \$37.80, provided there was no increase in the valuation of the home. They also reported that of the total county property taxes, \$330.86 is levied into the General Fund to support general operations of county government, \$10.00 is levied for payment of bonded indebtedness, and \$46.36 is levied for federal aid road and bridge projects.

No public comments were received during the hearing. Chairman McCallum closed the public hearing at 10:10 A.M.

After discussion, the following resolution was introduced:

RESOLUTION #2008-59

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Madison County property tax request for the prior fiscal year shall be the property tax request for the current fiscal year for purposes of the levy set by the County Board of Equalization unless the Board of Commissioners adopts a resolution setting the tax request at a different amount, and

WHEREAS, the Board of Commissioners has completed the budget process and determined that the property tax required to fund the operations of Madison County for the current fiscal year is different than the property tax request for the prior fiscal year, and

WHEREAS, a public hearing was held to hear and consider comments concerning the property tax request,

NOW, THEREFORE BE IT RESOLVED, that the property tax requests and levies for the 2008-2009 fiscal year for the respective funds of Madison County be set as follows:

Motion was made by Klein and seconded by Uhlir that the foregoing resolution be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.

County Attorney Joseph Smith appeared before the County Board to discuss an agreement with Zodiac Properties LLC for lease of office space for District Two Probation Office. He reported that from a legal standpoint the lease agreement is okay; however, he requested that a copy of the building plans be incorporated into the agreement. He stated that he has a concern from a policy standpoint because across the State of Nebraska the Probation Office is somewhat unstable. He explained that last year there was a legislative bill to split the Probation Office functions between parole and judiciary. He stated that although the legislative bill didn't pass; but, in his opinion, it is risky to approve a 15-year lease agreement for office space.

Commissioner Uhlir stated that if the duties of the Probation Office change, the county must still provide office space. County Attorney Joseph Smith responded that probation functions would remain as a judiciary function, but parole duties would transfer to a state function. Chairman McCallum explained that the legislative bill provided that if some of the functions were transferred to parole, the county would still be required to furnish office space. Commissioner Uhlir stated that Chief Probation Director Kathryn Liebers advised that the county would be required to furnish office space, even if the part of the duties became a parole function. County Attorney Joseph Smith reported that he recalled the legislative bill differently. He explained that he

understood that a compromise was made during the last legislative session that pre-sentencing would remain as a probation function and supervision would become a parole function. He explained that he made several recent calls to Lincoln and there is still dissatisfaction among many senators regarding the probation office functions.

County Highway Superintendent Richard Johnson reported that he spoke to Chief Probation Director Kathryn Liebers and she doesn't think that the legislative proposal would be approved; however, if there are probation office changes in the future, there is potential for sub-letting office space to other entities, such as the District Judge. County Attorney Joseph Smith stated that each District Court judge has office space in the courthouse. He explained that the Norfolk office was established for the convenience of divorce cases and civil matters.

County Attorney Joseph Smith explained that the lease agreement is for a 15-year term and the county can't simply get out at any time. He stated that the Board could breach the lease or negotiate a sub-lease. He stated that he is not fighting the Board on this matter; however, he wants the Board members to know there was a lot of discord last year regarding probation administration. Chairman McCallum stated that Chief Probation Director Kathryn Liebers and Commissioner Uhlir searched for a feasible building in Norfolk and construction of a new building that the county could lease was the most viable option.

County Highway Superintendent Richard Johnson reported that the base lease is in the amount of \$13.90 per square foot and this does not include the utility costs. He explained that the proposal provides that an additional \$1.50 per square foot could be added for utility costs for the first year of the lease, with annual adjustments thereafter. He reported that Pete Becker preferred that the county pay the utility costs because tenants tend to be more responsible regarding temperature settings in the building if they pay the utility costs. He also reported that if the county pays the actual utility bills, the other counties in the probation district would share a portion of the costs.

County Highway Superintendent Richard Johnson reported that Zodiac Properties submitted two site plans. He reviewed both site plans with the Board and the Board agreed that Site Plan No. 1 is the preferred option.

After discussion, it was moved by Uhlir and seconded by Klein to authorize the Board Chairman to execute a lease agreement with Zodiac Properties LLC for lease of office space for District Two Probation Office, with the County to pay the actual utility costs and the final site plan to be selected by Chief Probation Officer Kathryn Liebers. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.
